ORDER BELOW EXH. 1 .IN R.C.C. 119/2011.

The present criminal case has been filed by the complainant against accused for the offence punishable u/s 3-1(VIII), 3-1(X), 3-1(XI) 3-1(xv), 3-2(ii), 3-2(v), 3-2(vi), 3-2(vii) 4 of Prevention of Atrocity Act to SC and ST Act, 1989 r/w 120(b), 201, 300, 323, 466, 467, 471, 500, 504, 506(2), of Indian Penal Code. Today the complainant is present. Also, on perusal of record of the case it appears that, vide order below Exh. 1 dated 23/06/2011 My Ld. Predecessor has issued process against accused no. 6 for the offence punishable u/s 3(1)(x) of the Scheduled Caste and Scheduled Tribes (Prevention of Atrocities Act 1989) r/w section 406, 506(2) of Indian Penal Code. Also, the process was issued against other accused. But, the averments in the complaint clearly disclose that alleged complaint against accused was filed for the alleged offenses for which punishment is prescribed in Scheduled Caste and Scheduled Tribes (Prevention of Atrocities Act 1989). Also, it is important to take note that in view of clear language of the provisions of this Special Act, this Court has no jurisdiction to try the case and it is triable by Hon'ble Special Court as provided in the Act. Therefore, although My. Ld. Predecessor has issued process for the offenses under this Special Act, in my view it is just and necessary to commit the case to Hon'ble Court of Session, as it is exclusively triable by the said Court. Hence the order.

ORDER

- 1) The case R.C.C. No. 119/2011 be committed to the Hon'ble Court of Sessions, Khed.
- 2) The Record of the case, statement of witnesses, the documents, etc., which are to be produced in evidence

shall be sent to the Hon'ble Court of Sessions, Khed.

- 3) Accused are directed to remain present before the Hon'ble Court of Sessions, Khed, on 27/02/2025.
- 4) It is hereby notified to the District Government Pleader about commitment of the case to the Hon'ble Court of Sessions, Khed.
