ORDER

The petitioner filed a petition U/s. 13(3) of Registration of Births and Deaths Act 1969, seeking direction to the respondent to enter her date of birth in the register maintained by the respondent.

2.The brief facts of the petitioner's case is as follows:-

The petitioner was born on 27.07.1994. Petitioner's parents have not registered her date of birth in the records of Corporation of the City of Bengaluru. Now the petitioner is in need of her birth certificate. For the same when petitioner has approached the respondent, the office of the respondent reported that the event of birth of petitioner is not registered. Hence, the petitioner filed the present application.

3. Summons issued to the Respondent. Despite service of notice, Respondent did not appear. Accordingly, Respondent placed ex-parte.

4. The Petitioner got herself examined as PW-1 and got marked Ex.P-1 to Ex.P4.

8. **Point NO.1 :-** The petitioner deposed before the court that, petitioner was born on **27.07.1994 at #06, 2nd Cross, Chamundeshwari Nursary, Near Naidu Lyt, Jaraganahalli, J P Nagar, Bengaluru - 560 078** in this regard she has produced Non availability Certificate issued by BBMP as per Ex.P1, notary attested copies of Aadhar card, SSLC Marks Card and passport as per Ex.P2 to P4. Similarly, the event of birth of the petitioner is not registered in the office of the respondent is clear from the contents of Ex.P1. In order to prove her date of birth, petitioner has produced Ex.P2 and 3 i.e. notarized copies of Aadhar Card and SSLC Marks Card. I have perused the said documents, the date of birth of the petitioner is mentioned as **27.07.1994** even though the notice served on respondent, the respondent has not contested the case. There are no grounds to disbelieve case of the petitioner. Therefore, I am

of the opinion that the petitioner has made out a case for issue of direction to the respondent to enter the date of birth of **ASHA RAJANNA D/O. RAJANNA RAMANNA AND ARATHI CHINAPPA**, born on 27.07.1994 at #06, 2nd Cross, Chamundeshwari Nursary, Near Naidu Lyt, Jaraganahalli, J P Nagar, Bengaluru - 560 078 in the register of the births maintained by the respondent. Considering these aspects, I answered Point No.1 in the Affirmative.

9. **Point No.2 :** In the result, I proceed to pass the following:-

Jaraganahalli, J P Nagar, Bengaluru - 560
