ORDER

The matter is taken on board. The accused is present and voluntarily pleads guilty for the offence. I have gone through the offence punishable u/s 188 of Indian Penal Code, 1860. Offence punishable u/s. 188 of I.P.C. provides punishment of imprisonment for a term which may extend to one month, or with fine which may extend to two hundred for first clause, which is applicable in the present crime during the Covid-19 Pandemic. Heard accused on the point of sentence. Thus, considering the nature of offence and his submission, I proceed to pass following order;

Order

- (1) The accused is convicted for the offence punishable u/s 188 of Indian Penal Code vide Sec.252 of Criminal Procedure Code, 1973 and sentenced to pay fine of **Rs.200/- (Two Hundred Rupees)** in default of which he shall further undergo simple imprisonment for Three (03) days.
