**COMMITTAL ORDER**

The final report (charge-sheet) under sections 109, 189(2), 191(2) (3), 190, 125, 115(2), 352, 351(2)(3) of the Bhartiya Nyaya Sanhita 2023 is filed by Officer in charge of Police Station, Pargaon (Ka), after completion of investigation in Crime No.152/2025 registered with Police Station, Pargaon (Ka).

2) Accused are on bail and their are present before Court today. Accused are represented by their Ld. Advocate. Copy of police report, documents & statements of witnesses is supplied to them and thus, provisions of Section 230 of the Bhartiya Nagarik Suraksha Sanhita 2023 are duly complied with.

3) Offences under Section 109 of Bhartiya Nyaya Sanhita 2023 is exclusively triable by the Hon'ble Court of Sessions. Hence, case needs to be committed for trial to the Hon'ble Sessions Court at Khed-Rajgurunagar, Dist. Pune. Accused submitted that they have engaged an Advocate to represent them before the Hon'ble Sessions Court at Khed-Rajgurunagar, Dist. Pune. Hence, following order is passed :

**ORDER**

- A) Case be committed to the Hon'ble Sessions Court, at Khed-Rajgurunagar, Dist. Pune to be presented on **06/05/2026**.

- B) Accused are directed to remain present before the Hon'ble Sessions Court at Khed-Rajgurunagar, Dist. Pune on **06/05/2026 at 11.00 a.m.**
- C) The P.S.O., Police Station, Pargaon (Ka) is directed to furnish / produce the property seized as mentioned in the *Muddemal* list of the charge-sheet in the Hon'ble Sessions Court, at Khed-Rajgurunagar, Dist. Pune on or before **06/05/2026**. Issue letter to the P.S.O., Police Station, Pargaon (Ka) accordingly.
- D) Record of the case, documents, articles and properties which are to be produced in evidence be sent to Hon'ble Court of Sessions, at Khed-Rajgurunagar, Dist. Pune on or before **06/05/2026**.
- E) The Public Prosecutor be notified of the committal of the case to the Hon'ble Court of Sessions, at Khed - Rajgurunagar, Dist. Pune.
