



ORDER BELOW EXH.46 IN CRI.M.A. NO.82/2019

This application is filed by the applicant for permission of sale of attached property under order 21 Rule 64.

2. Respondent failed to file his say despite of sufficient opportunity. Hence, application proceed without his say. Heard learned Advocate for the applicant. Respondent and his advocate are absent. Hence, I proceed to decide this application on merit without argument of respondent. Perused application and record. It seems that my learned predecessor has passed the order below Exh.15 and directed to District Collector Satara for recovery of due maintenance by attachment of agricultural property of respondent. Thereby letter was issued to the Collector Satara and accordingly District Collector Satara attached the property and charge is entered on the 7/12 extract of Gat No.85 to the share of respondent. Accordingly, report has been filed. Now, applicant has filed the application and prayed for permission to sale said attached property for recovery of maintenance amount. On perusal of record, it seems that the respondent has not paid the due amount till date. Therefore, it is necessary to issue letter to Collector so as to recovery of maintenance by following the procedure as per law. Hence, I pass following order -

ORDER

Issue letter to the Collector, District-Satara for recovery of amount of Rs.9,00,000/- (Rupees Nine Lakhs) from respondent namely Prakash Suryakant Pawar from his share in Gat No. 85 situated at Koregaon which is attached by the order of this court, by following the procedure as per law and submit report alongwith recovered due maintenance amount in the court.
