:: COMMITTAL ORDER BELOW EXH.01 ::

The charge-sheet is filed with offence punishable under Sections 61(2), 309(4), 311, 332(b), 310(2), 115(2), 351(2) of Bhartiya Nyaya Sanhita. The offence punishable under Section 310(2) of B.N.S. is exclusively triable by Hon'ble Court of Sessions. **Accused No.1 Babusha Pingya @ Chinglya Kale, accused no. 2 Shubham Pingya @ Chingya Kale, accused no. 3 Ravi Lala Bhosale and accused no. 4 Kabir Umbrya Kale** are under trial, accused no. 1 to 3 are produced on V. C. at about 12.40 p.m. and accused no. 4 is produced through VC at about 12.45 p.m. They have no complaint. The copies of Police Report (Charge-sheet) and other documents filed there with by the prosecution have been supplied to the accused through their Ld advocate, as specified under section 230 of the B. N. S. S., 2023. Accused have informed that, they will make arrangement of their defence before the Hon'ble Court of Sessions by engaging his own Lawyer. Hence, it will be appropriate to commit the case to the Hon'ble Court of Sessions. Thus, following order is passed :-

- 1) The case is committed to the Hon'ble Court of Sessions, Khed-Rajgurunagar.
- 2) The Jail Authority shall produce accused before Hon'ble Sessions Court, Khed-Rajgurunagar on 20.07.2026 at 11:00 a.m.
- 3) The compliance of section 230 of the B. N. S. S., 2023 has been made.

- 4) The record of the case and the documents/articles which are to be produced in evidence shall be sent to the Hon'ble Court of Sessions at Khed-Rajgurunagar on or before 20.07.2026 positively.
- 5) The Public Prosecutor shall be notified about the committal of this case.
- 6) Investigating Officer shall produce the seized muddemal, if any, before the Hon'ble Court of Sessions, Khed-Rajgurunagar.
