ORDER BELOW EXH. 84 IN R.C.C. 229/2021

The present application has been filed the accused no. 1 Abhishek Maruti Parve for obtaining No Objection Certificate and for necessary directions to Passport Authority, Pune for renewal of his passport. Ld. APP filed her say at Exh. 85.

2. Read the application and say. Heard Ld. Advocate for the accused and Ld. APP.

3. Ld. Advocate for the accused submitted that, the accused is arraigned for the offence punishable under Sections 354, 324, 323, 143, 147 504 and 506 read with 34/149 of Indian Penal Code, 1860. It is further submitted that accused being a permanent resident of Narayangaon intends to travel abroad for his job purposes. However, his application for renewal of passport was rejected on the ground that, R.C.C. No. 229/2021 is pending against him. Therefore, he has filed the present application for No Objection from this Court for renewal of the passport.

4. Per contra, the Ld. APP argued that, if permission as prayed is granted there is a possibility that the accused may not be present before the Court for the trial. Hence, prayed that application be rejected. It is further submitted that the offence is serious in nature and he may evade trial post going to abroad. Hence, prayed that the No Objection Certificate not be granted to the accused.

5. On perusal of record, it appears that the accused is a resident of Narayangaon Tal. Junnar Dist. Pune and he is a citizen of India. He has produced the copy of letter dated 11/03/2026 of his company and his

Aadhar Card on record. Alongwith the present application he has produced his affidavit on oath in which he has contended that he is ready to obey all the conditions to be imposed by this Court. Considering the fact that, the accused is only 32 years old and wishes to seek better job opportunity abroad, it will be reasonable to grant him No Objection Certificate for renewal of passport. If merely, on the ground that, a criminal case is pending against him the present application is rejected, he will be deprived of the right to obtain a renewed passport and travel abroad for job purposes. Pertinently, the accused has till date duly complied with his bail conditions.

6. In view of the above discussion and notification dated 10th October 2019 in regards to Section 6(2)(f) of Passport Act, 1967 it will be appropriate to allow the present application subject to conditions. Hence, the following order.

ORDER

1. Application (**Exh. 84**) is allowed.
2. Accused no. 1 Abhishek Maruti Parve resident of Narayangaon Tal. Junnar Dist. Pune is granted No Objection Certificate for renewal of his passport no. AA399146 for a period of 10 years subject to the rules of Passport Authority and following conditions.
 - a. He shall not leave the country without obtaining the prior permission from this Court.
 - b. He shall furnish the itinerary of his travel schedule and necessary documents before leaving the country.
3. Issue letter to concerned passport authority.
