: JUDGMENT:

I have informed the accused that, he will be liable for imprisonment of Six months or fine of Rs. 5000/- for the offence punishable under section 84 of the Maharashtra Prohibition Act, , if he admits the offence. they are admitted the offence voluntarily. The accused submitted that, they are having poor economical condition. they have responsibility of their families. Considering that the accused have voluntarily admitted the offence and considering above facts, it will not proper to send the accused in to the Jail. It will also not proper to impose fine of full

amount. Hence, I pass following order.

ORDER

The accused are convicted vide section 252 of the Criminal Procedure Code for offence punishable under section 84 of the Maharashtra Prohibition Act 1949, and ordered to pay fine of **Rs. 1000 (One Thousand Rupees only)** each for offence punishable under section 84 for offence punishable under section 84 in default to undergo Simple Imprisonment of 15 days for each offence.
