**ORDER BELOW EXH. 21 IN CRI.M.A.NO. 354/2020**

1. This is an application filed by applicant for production of salary slip of respondent No.1 from concerned authority/company. Say called from the respondents.
2. It is contention of the applicant that the respondent is doing job in multinational company namely “Corning Technologies India Pvt. Ltd”. Therefore, it is necessary to call information of salary slip & other allowances of respondent from the said company, to come truth on record. If application is allowed, it will helpful to give justice. Hence, she prayed to allow the application.
3. Per contra, respondent has filed his say at Exh. 31 and resisted the present application. He has submitted that present application is not true and correct. It is illegal. Matter is pending for submitting affidavit of assets and liabilities of both the parties but only to prolong the matter applicant has filed present application. Respondent No. 1 is ready to file his affidavit of assets and liabilities. Applicant has to file her affidavit of assets and liabilities. Applicant has no right to call salary slip of respondent No. 1. Only to harass the respondent, applicant has filed present application. Therefore, he prayed to reject the application.
4. Heard both sides. Perused the record.

5. I have gone through the record. Case is pending for hearing of the interim maintenance application. Applicant has filed her affidavit of assets and liabilities at Exh. 25 and respondent No. 1 has filed his affidavit of assets and liabilities at Exh. 27. But applicant has taken objection as respondent No. 1 has given false information regarding his income. Applicant contended that respondent No. 1 is doing job in Corning Technologies India Pvt. Ltd. , D-237, MIDC, Phase II, MIDC Chakan, Tal- Khed, Dist- Pune. Matter is pending for hearing of interim maintenance application of the applicant since long. Therefore, at this juncture, it is necessary to call payment slip of the applicant from the concerned authority/company. If the payment slip called from the concerned, it will help to the Court to determine the real dispute between both the parties and to give complete justice to the both the parties. Hence, I pass following order.

**Order**

1. Application at Exh. 21 is allowed.
2. Issue witness summons to Corning Technologies India Pvt. Ltd. , D-237, MIDC, Phase II, MIDC Chakan, Tal- Khed, Dist- Pune, to produce certified copy of latest payment slip of respondent namely Umesh Sadashiv Somoshi, if any.
3. Applicant is directed to deposit witness bhatta as per rules.
