**ORDER BELOW EXH. 01**

Accused namely Gurunath Eknath Patil & Datta Shankar Jankar are produced on V.C. through jail authority. The Officer in charge of Kamshet Police Station, after the completion of the investigation in Cr. 2. The case be committed to the Hon'ble District &

Additional Sessions Judge-1, Vadgaon Maval, Pune, as per Section 232 of the Bharatiya Nagarik Suraksha Sanhita, 2023.

3. Accused are directed to appear before the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune on 10/02/2026 at 11:00 a.m.
4. The record of the case, the documents and articles, which are to be produced in evidence, shall be sent to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune.
5. The Police Station Officer, Talegaon Dabhade Police Station, be directed to produce muddemal property in the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune on or before 10/02/2026 positively.
6. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune.
7. Copies of police report and other documents for accused be sent to concerned jail authority immediately.
