ORDER BELOW EXH. 1

Accused namely No. 1 **Naresh Sajandas Rohra** was produced through V.C. by Kolhapur jail authority and No. 3 **Dhiraj Jethanand Valecha** was produced through V.C. by Satara jail authority. Other accused namely No. 2 **Manish Sureshlal Jagyashi** is present along with his Ld. Advocate. The Officer in charge of Lonavala City Police Station, after the completion of the investigation in Cr. No. 505/2024 for the offence punishable u/s. 70(1), 351(2), 351(3), 123 and Section 66(e) of the Information Technology Act has filed a final report.

2. Offence under Section 70(1) of the Bharatiya Nyaya Sanhita, 2023 is exclusively triable by the Hon'ble Sessions Court. Therefore, Case need to be committed to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune. Copies of police report and other documents have been supplied to the accused and duly complied vide Section 230 of the Bharatiya Nagarik Suraksha Sanhita, 2023. Hence, the present case will have to be committed to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune. Hence, the order :

ORDER

1. The jail authority is directed to produce accused No. 1 **Naresh Sajandas Rohra** and accused No. 3 **Dhiraj Jethanand Valecha** on 04/02/2026 at 11.00 a.m. without fail before the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune.

2. Accused No. 2 **Manish Sureshlal Jagyashi** is directed to appear before the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune on 04/02/2026 at 11:00 a.m.
3. The case be committed to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune, as per Section 232 of the Bharatiya Nagarik Suraksha Sanhita, 2023.
4. The record of the case, the documents and articles, which are to be produced in evidence, shall be sent to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune.
5. The Police Station Officer, Talegaon Dabhade Police Station, be directed to produce muddemal property in the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune on or before 04/02/2026 positively.
6. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune.
7. Copies of police report and other documents for accused Nos. 1 & 3 be sent to concerned jail authority immediately.
