

MHPU260085772025**ORDER BELOW EXH. NO. 10 IN RCC. NO. 1198/2025**

(Prakash vs. State)

The present application is filed under section 503 of BNSS Act, 2023 for return of vehicle. The learned advocate for applicant argued for granting custody of the seized vehicle Rikshwa bearing No. MH.14. J. P 3906 to the applicant.

2. The Learned A.PP and I.O have objected.
3. Heard learned Advocate for applicant and Ld. A.PP for state.
4. Police claimed to have seized said vehicle of the applicant in connection with Crime Registration No. 405/2025, Ravet P. S. for the offences under BNS of 2023. The documents produced by the applicant show that, applicant is the registered owner of seized vehicle Rikshwa bearing No. MH.14. J. P 3906. Hence, he is entitled for its custody under section 503 of BNSS Act, 2023.
5. The authority of **Sunderbhhai Ambalal Desai Vs. State of Gujarat, AIR 2003SC638** relied by the applicant's learned Counsel contains the directions to pass immediate and appropriate order for disposal of the seized articles like vehicles etc., instead of keeping them for a long time at the police station. The applicant's learned Counsel states the approximate value of the vehicle as Rupees 5,00,000/-. Necessary conditions may be imposed for securing production of the vehicle for identification purpose, during the trial. Hence, the application is allowed as under :

1. The applicant shall execute a supratnama bond before the Asstt. Supdt. of the Court, binding himself to produce the said vehicle as and when directed by the Court and in default, to forfeit the amount of Rs. 5,00,000/- to the Government.
2. The applicant shall furnish, at his own expenses, to the Officer-in-charge of Ravet Police Station, two self-attested colour photographs of the said vehicle, for its identification purpose. The police officer shall facilitate such photography. And applicant shall furnish true copy of documents of said vehicle to the concern police.
3. The Officer-in-charge of Ravet Police Station, shall upon receiving such photographs, countersign the same, prepare a possession receipt-cum-panchanama and verifying original Aadhar card of applicant, handover custody of the seized Rikshwa bearing No. MH.14. J. P. 3906 to the applicant and forward the photographs and possession receipt to the Court forthwith.
4. Supratnama Bond, Possession Receipt-cum-panchanama and R & P of this proceeding be tagged with the police report which may be filed in the above crime.
