ORDER BELOW EXH. 1

Accused namely **Nihar Gopal Vishwas @ Bishwas** r/o. Priya General Stores, Maskarnis Colony, Talegaon Dabhade, Tal Maval, Dist. Pune, is present along with his advocate. The Officer in charge of Talegaon Dabhade Police Station, after the completion of the investigation in C.R. No. 66/2025 for the offence punishable u/s. 123, 274, 275 & 223 of the Bharatiya Nyaya Sanhita, 2023 and u/s. 30(2)(a) of the Prevention of Food Adulteration Act has filed a final report.

2. Offence under Section 123 of the Bharatiya Nyaya Sanhita, 2023 is exclusively triable by the Hon'ble Sessions Court. 2. Accused is directed to appear before the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune on

22/08/2025 at 11:00 a.m.

3. The record of the case, the documents and articles, which are to be produced in evidence, shall be sent to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune.
4. The Police Station Officer, Talegaon Dabhade Police Station, be directed to produce muddemal property in the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune on or before 22/08/2025 positively.
5. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble District & Additional Sessions Judge-1, Vadgaon Maval, Pune.
