ORDER BELOW EXH. NO. 01 IN CRI.M.A. NO. 456/2026
(State Vs. Ashit Gujrati)

The present application is filed under section 503 of BNSS Act, 2023 for return of money. The learned advocate for applicant argued for granting custody of the seized amount to the applicant.

2. The Learned A.P.P has strongly objected to the application. According to I.O. the amount is present in the account of accused. He has no objection for giving interim custody of Rs. **31,729/-** to the applicant.

3. Heard learned Advocate for applicant and A.P.P for state.

4. Police claimed to have freeze/hold the account of accused situated in following particulars,

5. Hence, applicant is entitled for its custody under section 503 of the BNSS Act, 2023.

6. The authority of **Sunderbhhai Ambalal Desai Vs. State of Gujarat, AIR 2003SC638** relied by the applicant's learned Counsel contains the directions to pass

immediate and appropriate order for disposal of the seized articles like vehicles etc., instead of keeping them for a long time at the police station. Necessary conditions may be imposed for securing production of the amount during the trial. Hence, the application is allowed as under :

ORDER

1. The applicant shall execute a supratnama bond before the Asstt. Supdt. of the Court, binding himself to produce the said amount as and when directed by the Court and in default, to forfeit the amount of Rs.**31,729/-** to the Government.
2. The Nodel Officer/Branch Manager of following mentioned banks are directed to transfer Rs. Rs.**31,729/-** (Rupees Thirty One Thousand Seven Hundred and Twenty Nine only) to the account of applicant Ashit Gujrati forthwith.
