**:: ORDER BELOW EXH. 28 ::**

Heard Ld. Adv. Shri. A. M. Deshmukh for Opponent no. 2/Bajaj Allianz General Insurance Co. and Adv. Shri. J. A. Lele for Applicant/MSRTC. This application is taken out by Opponent no. 2 for staying M.A.C.P No. 130/2019.

02. This claim petition is filed by MSRTC for claiming damages towards damage to S. T. by vehicle of Opponent no. 1 against Vindhyavasini Logistic Pvt. Ltd and Bajaj Allianz General Insurance Co. The vehicle of the opponent no. 1 is insured with Opponent no. 2. The insurance policy is valid for the period from 18.08.2017 to 17.08.2018.

03. Ld. Adv. Shri. Deshmukh submitted that, Opponent no. 2 has filed the written statement and denied the contentions on the ground that the policy filed on record is fake, bogus and fabricated. He submits that vide letter no. 229/2025 dt. 09.10.2025 Addl. Director General of Police, CID, Pune has set up Special Investigation Team to investigate fraudulent matters. He further submits that Opponent no. 2 vide letter dt. 04.12.2025 submitted a list consisting of 56 matters to the Addl. Director General of Police, CID Pune, to investigate those matters through SIT and that the present MACP No. 130/2019 is mentioned at Sr. No. 45 in the said letter dt. 04.12.2025. He further submits that now SIT is to

investigate into it to identify culprits and therefore till completion of the investigation through SIT, the proceeding of MACP No. 130/2019 may stayed.

04. Ld. Adv. Shri. J. A. Lele filed say below Exh. 28 and opposed the application. He submits that, in the present case Opponent no. 2 has come out with the case that Insurance Policy is fake, bogus and fabricated and it is not case of Opponent no. 2 that the claim is fake and bogus one. He submits that the scope of inquiry of the SIT headed by Addl. Director General of Police, CID, Pune is very limited. He has drawn my attention to the letter dt. 09.10.2025 of the office of ADGP, CID, Pune and prayed for rejection of the application.

05. In view of the submissions of both sides I have perused the letter dt. 09.10.2025 of the office of ADGP, CID, Pune forming the SIT. The scope of inquiry of SIT is to look into the fake and bogus motor accident claims. Here the Opponent no. 2 is not come out with the case that the claim is false, fake and bogus. It seems that this application is taken out without seeing the scope of the inquiry to be done by the SIT. Therefore the application for stay of the proceeding by Opponent no. 2 is misconceived and without application of mind. Hence, I Pass the following order :-

**:: ORDER ::**

1. Application at Exh. 28 stands rejected and disposed off accordingly.
2. Applicant/MSRTC Shall file on record evidence affidavit on next date, without fail.
