**ORDER BELOW EXH. 1**

1] This is an application for issuance of legal Succession Certificate under Indian Succession Act, 1956.

2] Applicants have filed this application to recognize them as legal heirs of **Late Sadashiv Bapurao Malve**, who died intestate on 13/02/2023 at Sasun Hospital Pune. It is contended that, applicant No.1 is wife, applicant no.2 is mother, applicant no.3 is son & applicant no.4 is daughter of **Late Sadashiv Bapurao Malve**.

3] It is also contended that except applicants there are no other legal heirs to **Late Sadashiv Bapurao Malve**. It is further contended that applicants have not submitted any other application for securing Succession Certificate of deceased in any other court.

4] On receipt of the application, proclamation (Exh.24) has been proclaimed on 09/02/2026 and public notice is published in the daily newspaper "Raigad Nagari" dated 19/07/2025 at (Exh.14). After publication of the same, no one is appeared and filed any objection to present application within 30 days.

5] Perused the Affidavit (Exh.18) for examination-in-chief filed by applicant and documents filed by applicants i.e. verified copy of Death Certificate of **Late Sadashiv Bapurao Malve**, Verified copy of RC open

truck in the name of Late Sadashiv Bapurao Malve, Original copy of permit open truck in the name of Late Sadashiv Bapurao Malve, Xerox copy of Fitness certificate & Insurance open truck in the name of Late Sadashiv Bapurao Malve, Verified copy of birth certificate of deceased daughter and son, Verified copy of Power of Attorney given by Yamuna Bapurao Malve to Rani Sadashiv Malve, Claim Affidavit of applicant (Exh.18), verified copy of Aadhar Card of applicants.

6] On the perusal of application and record, it appears that objection is not raised by any person to issue Succession Certificate of **Late Sadashiv Bapurao Malve**, in favour of applicants. Hence, in view of above discussion I pass the following order -

**:: ORDER ::**

- 01 Application is allowed.
- 02 It is hereby declared that, applicant no.1 **Rani Sadashiv Malve**, applicant no.2 **Yamuna Bapurao Malve**, applicant no.3 **Virat Sadashiv Malve**, & applicant no.4 **Anshika Sadashiv Malve** are the legal heirs of **Late Sadashiv Bapurao Malve** and Succession Certificate-cum-Heir-ship Certificate under Section 372 of the Indian Succession and Bombay Regulation Act, 1856 be issued accordingly.
- 03 Applicants to deposit requisite court fees as per rule.
