Accused Ashutosh Dahiya @ Ashu is absent.

Accused Rakesh is present on bail.

Accused Amit Khatri produced from J/C.

Counsel Mr. Satpal Sharma, for accused Amit Khatri
and accused Rakesh.

Despite repeated calls since morning accused
Ashutosh Dahiya @ Ashu has not appeared. His Bail bond
forfeited.

NBWs be issued against him with notice to surety
u/s 446 CrPC for the NDOH.

Arguments have been addressed on the bail
application of accused Amit Khatri.

This is the second bail application u/s 483 BNSS for
grant of regular bail to accused Amit Khatri. It is stated that
accused Amit Khatri is 35 years of age and has clear past
antecedents except FIR No. 143/2025 u/s 115, 118(1), 126, 3(5)
and 351(3) BNS PS Kharkhoda wherein production warrants are
already issued against him. It is submitted that the wife of the
accused is ill and there is nobody to look after the family. He has
been falsely implicated in the present case and nothing has been

recovered from his possession. It is also stated that the charge-sheet has already been filed and the accused is not required for any further investigation and the accused is ready to comply with any condition that is imposed upon him.

IO SI Praveen is present, who has filed a detailed reply stating that scooty number DL11H 1931 was recovered at the instance of accused Amit Khatri @ Monu and Rakesh. The complainant also identified accused Amit Khatri in the TIP. Accused is already wanted in FIR no. 143/2025 and there is likelihood of his absconding, if granted bail.

In the facts and circumstances mentioned since the co-accused persons Rakesh at whose instance also the scooty was recovered, is already on bail. Considering the ground of parity as also the fact that the trial is going to take a long time, accused Amit Khatri @ Monu is admitted to bail on his furnishing a personal bond in the sum of Rs.25,000/- with one surety in the like amount, and subject to the following conditions :

- (1) the applicant/accused will not leave the city without prior permission of the court.
- (2) he shall appear before the court on each and every date.
- (3) he shall provide all his mobile numbers to the IO concerned, which shall be kept in working condition at all times and shall not change the mobile number without prior intimation to the IO concerned.
- (4) he shall not indulge in any criminal activity.
- (5) the applicant/accused will not threaten or influence the prosecution witnesses or tamper with evidence or create any sort of impediment in the trial etc.

It is clarified that nothing stated herein shall tantamount to an expression of opinion on the merits of the case.

Copy of this order be sent to the Superintendent Jail concerned.

The present bail application accordingly stands allowed and it be tagged with the main file.
