CIVIL MISC. APPLICATION NO.1071/2025**Smt. Kamini Harshad Kharunkar & 1 Ors. ... Applicants.****V/s.****NIL.****ORDER BELOW EXH. 1**

- 1] This is an application for issuance of Succession Certificate of the Indian Succession Act, 1956.
- 2] Applicants have filed this application to recognize them as legal heirs of **Late Harshad Harishchandra Kharunkar**, who died intestate on 04/09/2012 at wooded area, port Richey, Pasco country, Florida, America. Mother of the deceased namely Late Malati Harishchandra Kharunkar died on 20/04/2021 at Sanjivani Hospital Virar (west) Mumbai. Father of the deceased namely Harishchandra Babu Kharunkar died on 30/03/2024 at A – 203, Viva Swarganga Complex, Bolij Virar (west) Vasai Palghar. It is contended that, applicant No.1 is wife, applicant no.2 is son of **Late Harshad Harishchandra Kharunkar**.
- 3] It is also contended that except applicants there are no other legal heirs to **Late Harshad Harishchandra Kharunkar**. It is further contended that applicants have not submitted any other application for securing Succession Certificate of deceased in any other court.
- 4] On receipt of the application, proclamation (Exh. 08) has been proclaimed on 19/09/2025 and public notice is published in the daily newspaper “Dainik Kille Raigad” dated 23/08/2025 at (Exh.07). After publication of the same, no one is appeared and

filed any objection to present application within 30 days.

5] Perused the Affidavit (Exh.09) for examination-in-chief filed by applicants and documents filed by applicants i.e. verified copy of death certificate of **Late Harshad Harishchandra Kharunkar**, verified copy of death certificate of Late Malati Harishchandra Kharunkar, verified copy of death certificate of Late Harishchandra Babu Kharunkar, Verified copy of ICICI Bank statement Account No. 000401044067, Verified copy of ICICI Bank statement Account No. 000401083927, Verified copy of ICICI Bank statement Account No. 003901562065, Verified copy of Aadhar Card & Reshan Card of Applicant nos. 1 & 2.

6] On the perusal of application and record, it appears that objection is not raised by any person to issue Succession Certificate of **Late Harshad Harishchandra Kharunkar**, in favour of applicants. Hence, in view of above discussion I pass the following order -

:: ORDER ::

- 01 Application is allowed.
- 02 It is hereby declared that, Applicant No.1 **Kamini Harshad Kharunkar** & Applicant No. 2 **Mohit Harshad Kharunkar** are the legal heirs of **Late Harshad Harishchandra Kharunkar**, and Succession Certificate be issued accordingly.
- 03 Applicants to deposit requisite court fees as per rule.
