Application for Heirship Certificate under the Bombay Regulation Act.

JUDGMENT

(Delivered as on 09/04/2026)

Applicants have filed the present application for Heirship Certificate under the Bombay Regulation Act.

02. **Facts of present application in nutshell are as under:-**

Applicant No.1 to 3 are Granddaughter of Smt. Shantabai Mahadu Kamble. Smt.Shantabai Mahadu Kamble has died on 15/05/2004. Mother of applicant namely Smt.Shakuntala Mahadu Kamble has also died on 28/07/2020. Deceased Smt.Shantabai Mahadu Kamble not executed any will before death. Applicants are only legal heirs to deceased. Hence, applicants prayed for heirship certificate through this application.

03. Citation notice was issued. Proclamation was published in "Global Times" newspaper on 06/02/2026 calling objection from the public at large. After issuance of citation notice and proclamation in the daily newspaper, no one appeared and raised objection to the present application.

04. Considering pleadings of applicants and the submission of the learned Advocate for applicants, following points arise for my determination to which I have recorded my findings against each of them for the reasons given below:-

REASONS

As to Point No.1 :-

05. In order to establish the claim on behalf of applicant, applicant No.1 Ku.Sujata Mahadu Kamble (A.W.1) has filed his affidavit of examination-in-chief at Exh.11. In support of his oral evidence, applicants have filed documentary evidence i.e. original copy of death certificate of deceased Smt. Shantabai Mahadu Kamble at Exh.12, original copy of death certificate of deceased Smt.Shakuntala Mahadu Kamble at Exh.13, verified copy of adhar card of applicant No.1 at Exh.15, verified copies of adhar cards of applicant No.2 to No.3 at Exh.18 to 19 respectively, Applicants have filed their evidence close pursis at Exh.16, Report of citation notice is at Exh.7.

06. Applicant No.1 Ku.Sujata Mahadu Kamble (A.W.1) has reiterated near about all contents of application Exh.11 in his affidavit of examination-in-chief at Exh.11. In

order to avoid the repetition of the same, I find it proper not to reproduce the same.

07. Evidence of applicant No.1 Ku.Sujata Mahadu Kamble (A.W.1) has remained unchallenged as none of raised any objection to the application. Documentary evidence corroborates the contention of applicants.

08. As discussed above, despite issuance of citation notice and paper publication, none of raised any objection to the application. Consequently, evidence of applicant No.1 Ku.Sujata Mahadu Kamble(A.W.1) remained unchallenged. Since evidence of the applicant remained unchallenged. Hence, findings on point No.1 is recorded in the affirmative.

As to Point No.2 :-

09. As per evidence of applicant No.1 Ku.Sujata Mahadu Kamble (A.W.1) at Exh.11, applicants have prayed for issuance of legal heirship certificate in their name. Moreover, documents shows that applicants are legal heirs of the deceased Smt.Shantabai Mahadu Kamble. However, it is to be noted that issuance of legal heirship certificate is only for the purpose of recognition and it does not create any right in favour of applicants. Hence, the findings on the Point No.2, I pass following order.

ORDER

1)	Application is allowed.
2)	Legal Heirship Certificate be issued in the name of applicant No.1 namely Ku.Sujata Mahadu Kamble , and

	applicant No.2 namely Smt. Shital Rahul Deshmukh @ Reshma Anil Dhende and applicant No.3 namely Nilam Milind Kumar Bhangare @ Nilam Anil Dhende on furnishing stamp and certificate issue as per Appendix-B as legal heirs of deceased Smt.Shantabai Mahadu Kamble .
3)	Applicants shall not be entitled to claim any other benefit on the basis of the said legal heirship certificate issued in their name without following due procedure of law.
4)	Issue Legal Heirship Certificate accordingly. (Pronounced in open Court)
