Application for Heirship Certificate under the Bombay Regulation Act.

JUDGMENT

(Delivered as on 16/04/2026)

Applicants have filed the present application for Heirship Certificate under the Bombay Regulation Act.

02. **Facts of present application in nutshell are as under:-**

Applicant No.1 is wife and applicant No.2 is Son, applicant No.3 and 4 is daughter of Kisansingh Laximansingh Pardeshi. Kisansingh Laximansingh Pardeshi has died on 12/12/2008. Deceased Kisansingh Laximansingh Pardeshi not executed any will before death. Applicants are only legal heirs to deceased. Hence, applicants prayed for heirship certificate through this application.

03. Citation notice was issued. Proclamation was published in "Global Times" newspaper on 08/08/2025 calling objection from the public at large. After issuance of citation notice and proclamation in the daily newspaper, no one appeared and raised objection to the present application.

04. Considering pleadings of applicants and the submission of the learned Advocate for applicants, following points arise for my determination to which I have recorded my findings against each of them for the reasons given below:-

REASONS

As to Point No.1 :-

05. In order to establish the claim on behalf of applicant, applicant No.2 Vijaykumar Kisansingh Pardeshi (A.W.1) has filed his affidavit of examination-in-chief at Exh.11. In support of his oral evidence, applicants have filed documentary evidence i.e. verified copy of death certificate of deceased Kisansingh Laximan singh Pardeshi at Exh.16, verified copy of death certificate of deceased Sanjay Kisansingh Pardeshi at Exh.17, verified copies of adhar cards and pan cards of applicant No.1 to 4 at Exh.12 to 15 respectively, Applicants have filed their evidence close pursis at Exh.19, Report of citation notice is at Exh.7.

06. Applicant No.2 Vijaykumar Kisansingh Pardeshi (A.W.1) has reiterated near about all contents of application Exh.11 in his affidavit of examination-in-chief at Exh.11. In order to avoid the repetition of the same, I find it proper

not to reproduce the same.

07. Evidence of applicant No.2 Vijaykumar Kisansingh Pardeshi (A.W.1) has remained unchallenged as none of raised any objection to the application. Documentary evidence corroborates the contention of applicants.

08. As discussed above, despite issuance of citation notice and paper publication, none of raised any objection to the application. Consequently, evidence of (A.W.1) remained unchallenged. Since evidence of the applicant remained unchallenged. Hence, findings on point No.1 is recorded in the affirmative.

As to Point No.2 :-

09. As per evidence of applicant No.2 Vijaykumar Kisansingh Pardeshi (A.W.1) at Exh.11, applicants have prayed for issuance of legal heirship certificate in their name. Moreover, documents shows that applicants are legal heirs of the deceased Kisansingh Laxmansingh Pardeshi. However, it is to be noted that issuance of legal heirship certificate is only for the purpose of recognition and it does not create any right in favour of applicants. Hence, the findings on the Point No.2, I pass following order.

ORDER

1)	Application is allowed.
2)	Legal Heirship Certificate be issued in the name of

	applicant No.1 Tarabai Kisansingh Pardeshi , namely, and applicant No.2 Vijaykumar Kisansingh Pardeshi , applicant No.3, Chaya Pattar , applicant No.4 Vanita Pradip Rajput , namely on furnishing stamp and certificate issue as per Appendix-B as legal heirs of deceased Kisansingh Laxmansingh Pardeshi .
3)	Applicants shall not be entitled to claim any other benefit on the basis of the said legal heirship certificate issued in their name without following due procedure of law.
4)	Issue Legal Heirship Certificate accordingly. (Pronounced in open Court)
