Application for Heirship Certificate under the Bombay Regulation Act.

JUDGMENT

(Delivered as on 01/04/2026)

Applicants have filed the present application for Heirship Certificate under the Bombay Regulation Act.

02. **Facts of present application in nutshell are as under:-**

Applicant No.1 is daughter, applicant No.2 is daughter, applicant No.3 is son and applicant No.4 is daughter of Madhuri Meghashyam Narkar. Madhuri Meghashyam Narkar has died on 18/12/2013. Husband of Madhuri Meghashyam Narkar Namely Meghashyam Ghanshyam Narkar has died on 28/09/1993. Mother of Madhuri Meghashyam Narkar is also died. Deceased Madhuri Meghashyam Narkar not executed any will before death. Applicants are only legal heirs to deceased. Hence, applicants prayed for heirship certificate through this application.

03. Citation notice was issued. Proclamation was published in "Global Times" newspaper on 15/01/2026

calling objection from the public at large. After issuance of citation notice and proclamation in the daily newspaper, no one appeared and raised objection to the present application.

04. Considering pleadings of applicants and the submission of the learned Advocate for applicants, following points arise for my determination to which I have recorded my findings against each of them for the reasons given below:-

REASONS

As to Point No.1 :-

05. In order to establish the claim on behalf of applicant, applicant No.2 Mohini Shashikant Palkar (A.W.2) has filed his affidavit of examination-in-chief at Exh.11. original copy of death certificate of deceased Meghashyam Ghanshyam Narkar at Exh.12, In support of her oral evidence, applicants have filed documentary evidence i.e. verified copies of adhar cards of applicant No.1 , No.3 and No.4 at Exh.13 to 15 respectively & verified copy of adhar card of applicant No.2 at Exh.17, verified copy of Index No.2 at Exh.18, original copy of death certificate of deceased Madhuri Meghashyam Narkar at Exh.22

Applicants have filed their evidence close pursis at Exh.23, Report of citation notice is at Exh.7.

06. Applicant No.2 Mohini Shashikant Palkar (A.W.2) has reiterated near about all contents of application Exh.11 in his affidavit of examination-in-chief at Exh.11. In order to avoid the repetition of the same, I find it proper not to reproduce the same.

07. Evidence of applicant No.2 Mohini Shashikant Palkar (A.W.2) has remained unchallenged as none of raised any objection to the application. Documentary evidence corroborates the contention of applicants.

08. As discussed above, despite issuance of citation notice and paper publication, none of raised any objection to the application. Consequently, evidence of applicant No.2 Mohini Shashikant Palkar (A.W.2) remained unchallenged. Since evidence of the applicant remained unchallenged. Hence, findings on point No.1 is recorded in the affirmative.

As to Point No.2 :-

09. As per evidence of applicant No.2 Mohini Shashikant Palkar (A.W.2) at Exh.11, applicants have prayed for issuance of legal heirship certificate in their name. Moreover, documents shows that applicants are legal heirs of the deceased Madhuri Meghashyam Narkar. However, it is to be noted that issuance of legal heirship certificate is only for the purpose of recognition and it does

not create any right in favour of applicants. Hence, the findings on the Point No.2, I pass following order.

ORDER

1)	Application is allowed.
2)	Legal Heirship Certificate be issued in the name of applicant No.1 namely Archana Annaji Sawant , applicant No.2 namely Mohini Shashikant Palkar applicant No.3 namely Mangesh Meghsham Narkar & applicant No.4 namely Mrunal Shailendra Dhotre on furnishing stamp and certificate issue as per Appendix-B as legal heirs of deceased Madhuri Meghashyam Narkar .
3)	Applicants shall not be entitled to claim any other benefit on the basis of the said legal heirship certificate issued in their name without following due procedure of law.
4)	Issue Legal Heirship Certificate accordingly. (Pronounced in open Court)
