Deposition of Witness No. 05 for the State

Examination-in-chief by Ld. APP Shri. V.S.Mhatre, for the State

01. On 22/06/2020 I was working at Sub-District Hospital, Roha on the post of Medical Officer. On that day, at about 3.20 p.m. patient namely Nisha Mukesh Chorge had been brought to our hospital by her relative. She had been referred by the police of Police Station, Roha. She was having history of assault by known person by means of hard object.

02. On the examination of Nisha Mukesh Chorge, I found following injuries on her person.

i.e. i) Laceration injury on left frontal bone area. The size of said injury was 3cm x 1cm x 01cm in size.

ii) Superficial laceration injury on left temporal parietal region. The size of said injury was 1cm in diameter.

03 The nature of supra injuries were simple. They were caused prior to 01 hour. They were caused by hard object. I had given her necessary medical treatment.

04. After the medical examination of said patient, I issued certificate that regard. Now, the certificate dated 23.06.2020 is shown to me. It bears my signature. Contents of the said certificate are true and correct. It is marked at **Exh.37**.

05. The injuries mentioned in the certificate (Exh.37) are possible if a person is beaten by Articles A and B.

Examination-in-chief is completed.

Cross examination by adv. Shri M.K.Shinde for the accused.

06. It is true to say that, the said patient had been to our hospital during the Covid period, At that time examination of the patient had been conducted by wearing kit, Today I have not brought original MLC register with me, It is necessary to issue MLC certificate on the same day in cases referred by the police. The witness voluntarily stated that the patient had been brought by her relative.

07. It is true to say that, MLC (Exh 37) shows that the said patient had been brought by Roha Police Station, The said document nowhere shows that the patient had been brought to our hospital by her relative and she was referred by Roha Police.

08. It is true to say that, left temporo parietal region is situated above the ears. It is not true to say that, left frontal area is situated at many places on the person's body. It is true to say that, if a person fell on the earth then he may sustained injuries mentioned in the certificate (Exh.37). The witness voluntarily stated that person receives abrasion injuries if he fell on the earth.

09. It is not true to say that, On 22/06/2020 I was not working at Sub-District Hospital, Roha as post of Medical Officer, On that day at about 3.20 p.m. patient namely Nisha Mukesh Chorge had not been brought to our hospital by her relative, She had not been referred by the police of police station, Roha, She was not having history of assault by known person by means of hard object, on the examination of Nisha Mukesh Chorge, I did not find following injuries on her person

i.e. i) Laceration injury on left frontal bone area. The size of said injury was 3cm x 1cm x 01cm in size.

ii) Superficial laceration injury on left temporal parietal region. The size of said injury was 1 cm in diameter.

10. It is not true to say that, the nature of supra injuries were not simple, they were not caused prior to 01 hour, they were not caused by hard object, I had not given her necessary medical treatment, After the medical examination of said patient, I had not issued certificate that regard, the certificate dated 23.06.2020 does not bear my signature, Contents of the said certificate are not true and correct, The injuries mentioned in the certificate (Exh.37) are not possible if a person is beaten by Articles A and B, I deposed incorrect today before the court.
