The accused has pleaded guilty in the present matter. Hence, he needs to be convicted. I have explained him in vernacular language the consequences for pleading guilty. I am satisfied that accused has voluntarily pleaded guilty. The accused is heard on point of sentence. The accused submitted that he be released on fine and he undertakes that he would not commit similar type of offense. The accused submitted that, this is his first offense, hence lenient view be taken by court and prayed to impose minimum fine. I am convinced that, looking into the age of accused and his strata of society which he belongs, minimum fine would meet the ends of justice. In the result I am inclined to pass following order.

**ORDER**

- 1) The accused is convicted for the offence punishable under section 285 of BNS, 2023 vide section 275 of the BNSS, 2023.
  
- 2) The accused is directed to pay fine of Rs.200/- (Rs. Two Hundred only) for the offence punishable under Section 285 of BNS, 2023. In default of payment of fine, accused shall suffer simple imprisonment for 2 (Two) days.
