Examination-in-chief by learned A.P.P. Shri. Chavan

1. In the year 2023 I was working as medical officer at Indira Gandhi Rural Hospital Uran. On 25.06.2023 patient Wazi Kasam Temkar came to my hospital for treatment at 3:30 p.m. He was assaulted by 2 to 3 known peoples. On His examination I found total 3 injuries on his body. First Injury was contusion of the size 3 x 3 c.m. On his right side of neck. That injury might have caused by hard object and was of simple in nature. Age of that injury was less than one hour.

2 Second injury was contusion of the size 15 x 2 x 0.5 c.m. on his right shoulder which might have caused by hard object and that injury was also simple in nature. For this injury he was advised for X-Ray

3 Third injury was contusion of the size 4 x 4 c.m. on his right and left Shoulder. That injury was also might have caused by hard object. That injury was also of simple in nature.

4. I have also examined another patient Marzan Rafik Tungekar

on the same day and time. I have found total four injuries on his body. First injury was laceration of size 0.5 x 0.5 x 1 c.m. on his upper lip edge. That injury might also have caused by hard object and was of a simple in nature. Second injury was laceration of the size 0.5 x 0.5 x1 c.m. on his lower lip. That injury might also have caused by hard object and was simple in nature. Third injury was laceration of the size 0.5x 0.5 x 1 c.m. on his lower lip. That injury might have cause by hard object and simple in nature. Last injury was contusion of the size 2 c.m. in diameter on his jow. That injury might have caused by hard object and was simple in nature.

5. After examining both the patient I have given primary treatment to them. Now the injury certificate shown me are issued by me and it bears my signatures and its contents are true and correct. Therefore injury certificates are hereby Exhibited as exhibit No 17 and 18 respectively.

6. Patient Wajid has told me who has assaulted and by what means. He has not told names of the person who assaulted him. On examination of Wajid I do not found injury on his chest. It is correct to say that patient Marzan also not stated the names of the person who assaulted him. It is not correct to say that on 25.06.2025 at about 3:30 p.m. I have examined patient Wajid and Marzan. It is correct to say that If any person falled down from the motorcycle on rough road then the injuries mentioned in injury certificate can occur. It is not correct to say that the help prosecution I depose falls. It is not correct to say that on the mere request of police I have issued injury certificates.
