## AWARD


The dispute between the parties having been referred for determination to the Lok Adalat and the parties having compromised/ settled the case/matter, the following award is passed in terms of the settlement:


### Terms of Compromise


The Respondent no.2 **Divisional Manager, Go Digit General Insurance Company Limited** do deposit **Rs.5,00,000 (Rs. Five lakhs only)** inclusive the amount of No Fault Liability, within **six weeks** from the date of Award, in default, the claimants are entitled to claim **interest @ 9% p.a.** thereon, from the date of Compromise. The claimants are waiving their rights to recover the claim against Respondent No.1.

Out of the amount payable to the claimants; claimant no.1 amount of **Rs.2,00,000/- (Rs. Two lakh fifty thousand only)** & claimants no.2 & 3 amount of **Rs.1,50,000/- (Rs. One lakh fifty thousand only)** each, be paid.



The parties are informed that the Court Fee, if any, paid by any of them, shall be refunded.

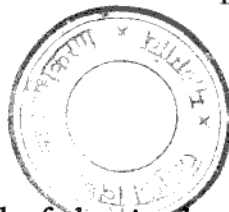
