Three lakhs Twenty five thousand only)** inclusive the amount of No Fault Liability, within **Eight weeks** from the date of Award, in default, the claimant is entitled to claim **interest @ 9% p.a.** thereon, from the date of Compromise. The claimant is waiving his right to recover the claim against Respondent No.1.

The parties are informed that the Court Fee, if any, paid by any of them, shall be refunded.




