That you on 23.12.2019 at about 11.30 p.m. within the limits of village Pilosari, Tal. Sudhagad, Dist. Raigad, on stone quarry of Surendra Patil you were member of an unlawful assembly

and in prosecution of common object of said assembly and thereby committed an offence punishable under **Section 143 r/w.149** of Indian Penal Code within my cognizance.

Further, on the above date, time and place during the course of same transaction you were member of an unlawful assembly and in prosecution of common object and committed an offence of rioting and thereby committed an offence punishable under **Section 147 r/w. 149** of Indian Penal Code and within my cognizance.

Further, on the above date, time and place during the course of same transaction you were member of an unlawful assembly and in prosecution of common object and were at the time armed with a deadly weapon like iron rod and wooden stick for rioting and thereby committed an offence punishable under **Section 148 r/w. 149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction, you were member of an unlawful assembly and in prosecution of common object voluntarily caused hurt to complainant & witnesses and thereby committed an offence punishable under **Section 323 r/w. 149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you were member of an unlawful assembly and in prosecution of common object of said assembly you accused **No.01** voluntarily causing hurt to Pramod Mane, by dangerous weapons by means iron rod & also accused No.02 to 08 voluntarily causing hurt to Pramod Mane, by dangerous weapons by means wooden stick, likely to cause death and thereby committed

an offence punishable under **Section 324 r/w.149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you were the members of an unlawful assembly and in prosecution of common object of such assembly, you accused No.01 took away the five tola gold necklace weighing 300 ml & half tola gold bar and band from right ear from the informant and thereby committed an offence punishable under **Section 327 r/w.149** of the Indian Penal Code, within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you were the members of an unlawful assembly and in prosecution of common object of such assembly, intentionally insulted informant & witnesses in filthy language and thereby gave provocation, intending and knowing it to be likely that such provocation will cause them to break the public peace or to commit any other offence and thereby committed an offence punishable under **Section 504 r/w.149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you were the members of an unlawful assembly and in prosecution of common object of such assembly, commits criminal intimidation and thereby committed an offence punishable under **Section 506 r/w.149** of the Indian Penal Code within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you were the members of an

unlawful assembly and in prosecution of common object of such assembly, you accused No.01 intending to insult the modesty of informant, uttered the words like 'तू पाली येथे भेटलीस तर तुला झवून काढीन' and thereby committed an offence punishable under **Section 509 r/w. 149** of the Indian Penal Code, within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you were the members of an unlawful assembly and in prosecution of common object of such assembly, committed by causing wrongful loss or damage to door of car of the complainant and thereby committed an offence punishable under **Section 427 r/w. 149** of the Indian Penal Code, within my cognizance.

Further Further, on the above day, date, time and place during the course of same transaction you accused No.01 to 08 disobeys order of the District Magistrate, Raigad-Alibag order was in force for preservation of public peace or public safety by notification publicly promulgated and thereby committed an offence punishable under **Section 37(1)(3) r/w. 135** of the Maharashtra Police Act, 1951, within my cognizance.

And I hereby direct that you be tried by me on the above said charge.
