Further, on the above day, date, time and place during the course of same transaction you were the members of an unlawful assembly and in prosecution of common object of such assembly, intentionally insulted complainant & witness in filthy language and thereby gave provocation, intending and knowing it to be likely that such provocation will cause her to break the public peace or to commit any other offence and thereby committed an

offence punishable under **Section 504 r/w.149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you were the members of an unlawful assembly and in prosecution of common object of such assembly, commits criminal intimidation and thereby committed an offence punishable under **Section 506 r/w.149** of the Indian Penal Code within my cognizance.
