Raigad, you accused No.01 to 21 were members of an unlawful assembly and in prosecution of common object of said assembly and thereby committed an offence punishable under **Section 143 r/w.149** of Indian Penal Code within my cognizance.

Further, on the above date, time and place during the course of same transaction you accused No.01 to 21 were members of an unlawful assembly and in prosecution of common object and committed an offence of rioting and thereby committed an offence punishable under **Section 147 r/w. 149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you accused No.01 to 21 were members of an unlawful assembly and in prosecution of common object of said assembly you voluntarily causing hurt to the complainant Mahesh Chandrakant Thakur and witnesses by dangerous weapons by means wooden sticks & stone, likely to cause death and thereby committed an offence punishable under **Section 324 r/w.149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction, you accused No.01 to 21 were members of an unlawful assembly and in prosecution of common object voluntarily caused hurt to the complainant & witnesses and thereby committed an offence punishable under **Section 323 r/w. 149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you accused No.01 to 21 were the members of an unlawful assembly and in prosecution of common object of such assembly, intentionally insulted complainant & witnesses in filthy language and thereby gave provocation, intending and knowing it to be likely that such provocation will cause her to break the public peace or to commit any other offence

and thereby committed an offence punishable under **Section 504 r/w.149** of Indian Penal Code and within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you accused No.01 to 21 were the members of an unlawful assembly and in prosecution of common object of such assembly, commits criminal intimidation and thereby committed an offence punishable under **Section 506 r/w.149** of the Indian Penal Code within my cognizance.

Further, on the above day, date, time and place during the course of same transaction you accused No.01 to 21 were the members of an unlawful assembly and in prosecution of common object of such assembly, committed by causing wrongful loss or damage to the swift desire car No.MH-04 ET-5734 of the complainant and thereby committed an offence punishable under **Section 427 r/w. 149** of the Indian Penal Code, within my cognizance.
