The applicant/accused -Deepak Narayan Dandekar moved this application for extension of bail period granted by this court dated 05.06.2023 on medical ground.

3. Points for the determination and my findings thereon for the reasons stated below ;

## REASONS

4. Perused application, say filed. Heard learned advocate Shri.Y.J.Gangan for the applicant/accused as well as learned A.P.P. Shri.C.Y.Patil for the State.

### AS TO POINTS NO. I AND II :

5. The present applicant is accused No.1 in a prosecution bearing Sessions trial No.71/2023 for the offence under Section 435, 440, 285, 286, 120-B, 201, 308, 34 of the Indian Penal Code and Section 4(A)(1) of the Explosive Substances Act. The present applicant is the kingpin of the crime. His bail applications are dismissed by this court as well as by Hon'ble High Court. His second application for bail on medical ground before Hon'ble High Court is disposed of with liberty to file fresh application before this court on medical ground. Accordingly, he moved application vide Exh.4 and same is allowed by this court as per order Dated 05.06.2023.

6. The said bail period on medical ground was for a period of three months. The said period is over on 05.09.2023. The applicant moved application for extension on the same day. Thus, as on date for hearing of this application one month is already over. Now the applicant request for extension of one month. He appended recent health update issued by Sanjivani

Hospital. The applicant has undergone surgery, however still he is facing health issues post surgery like as burning and blood in urine. Thus according to him, he requires one more month to overcome with this issue.

7. The medical facility is not available with the hospital appended to the Talaja Jail. He has taken treatment at higher center. He undergone surgery. Now looking to his health update and almostly he is cured as such, grounds are justified for extension of one month bail period on medical ground. In fact, this liberty was granted by this court in earlier order dated 05.06.2023 itself. Hence, I answer Point No.I in the affirmative. With this, I pass following order ;

### **ORDER**
