ORDER BELOW EXH.45 IN CRIMINAL APPEAL NO.7/2019
(OLD NO.22/2011)
(DATED 16/12/2022)

1] The appellant **Dhananjay Krishna Patil** in Cri.Appeal No.7/2019 (old No.22/2011) has preferred the present application for grant of permission to renew the passport, for a period of 10 years.

2] Heard appellant. He submitted that, he was holding the Passport bearing No.K8918551, which expired on 02/12/2022. Appellant has to travel abroad for his professional purpose and hence, he has made necessary application for renewal of passport. Appellant inquired with the Passport Authority and he was informed that he will be required to secure the new passport as the existing passport has expired and also informed that, the permission of court is required for renewal of Passport as well as for traveling abroad during pendency of matter.

3] Appellant has filed on record copy of his passport, application made to passport authority, copy of gazette issued by the Ministry of External Affairs dated 25/08/1993, copy of details of his tour at Europe. Appellant submitted that, necessary

directions be given to the Passport Authority, for renewal of his passport.

3] Ld.Adv.for the respondent filed say vide Exh.48 and raised objection and submitted that appeal is against the order of conviction. If appellant obtained passport, he may flee to abroad.

4] Upon hearing the Ld.Advocates and considering the nature of offence and documents filed by appellant, I am of the view that, the concerned authority can be given directions to renew passport of the appellant. So also, considering the need of the appellant to travel abroad, necessary permission can be given with certain conditions. Hence following order.

ORDER

- 1] Application Exh.45 is allowed.
- 2] The Passport Authority is directed to renew/issue passport to the appellant Shri.Dhananjay Krishna Patil as per the rules and conditions mentioned in the gazette notification dated 25/08/1993, for a period of five years.
- 3] Appellant Dhananjay Krishna Patil is allowed to travel abroad with further directions to give the details of his journey and residence during the said period in advance to the Court.
- 4] Appellant to give his schedule of traveling abroad to the Court before hand.

- 5] Appellant to attend the Court dates regularly.
- 6] Appellant/accused shall file an undertaking that, in his absence he will make necessary arrangement, to advance submissions on his behalf and the appeal will not be prolonged.
