Applicant/accused No.1 Minali Raj Pandey has filed these applications for relaxation of condition No.(3) in common bail order passed below exhibit No.8. According to accused No.1 she was directed to attend concerned police station on every second and fourth Monday till further orders. This order was passed on 23/09/2024. Till date accused No.1 has obeyed this condition. However, on 31/10/2024 accused No.1 had undergone spine operation and she is taking treatment. For this reason she has sought either relaxing said stipulation or modifying it.

2. Say of prosecution, IO alongwith victims was called on 08/01/2025, however, say is not filed.

3. Heard Ld.Adv.for applicant No.1

4. Applicant/accused No.1 has placed on record photocopy of her discharge summary of Kharghar Multispeciality Hospital. On perusal of same, it reveals that, applicant/accused had undergone treatment for her spine.

5. Investigating officer has failed to respond. From 23/09/2024 accused No.1 has obeyed stipulation to attend police station. Admittedly charge-sheet is filed and matter is pending for framing of charge. In such circumstances there is no need for accused No.1 to attend police station twice in month. Instead applicant/accused No.1 to file an undertaking before this Court that, she will attend each and every date and in case she remains absent, on her behalf her advocate will remain present. Accordingly I pass following order.

ORDER

1. Application Exh.33 and 40 in Special (MPID) Case No.92/2024 and 93/2024 are allowed.
2. In common bail order dated 23/09/2024 passed in Special (MPID) case No. 92/2024 and 93/2024 stipulation No.(3) stands canceled.
3. Applicant/accused No.1 Minali Raj Pandey to file an undertaking that she will regularly attend dates of these matters, in case she remains absent, her Advocate will conduct proceeding.
4. Inform concerned police station.
5. Copy of order be placed below Exh.33 as well as Exh.40.
