ORDER BELOW EXHIBIT 4 SESSIONS CASE NO.107/2022  
(DATED 16/08/2022)**

1] Applicant **Om Prakash Anmaldhari Yadav** has filed instant application u/sec.457 of Cr.P.C. for getting custody of the seized muddemal property i.e. Pulsor motorcycle which is seized by Nhava Sheva police station in C.R.No.38/2022.

2] Applicant has filed his ownership documents of the seized vehicle i.e. R.C.Book, insurance policy. Prosecution has given no objection and submits that, on terms and conditions vehicle should be return.

3] Heard Ld.Adv.for the applicant and Ld.APP.

4] Prima facie the investigation officer had seized black colour Pulsor Gloos Pewter Grey motorcycle bearing No.MH-03/DW-9039. From the vehicle particulars applicant Shri Om Prakash Amaldhari Yadav is the registered owner of the said vehicle. If the vehicle is kept idle at police station, it will get damage. Hence, by imposing certain conditions, the vehicle can be returned to the registered owner. Hence, I pass following order.

**ORDER**

1. Application Exh.4 is allowed.

2. Pulsor RS 200 Gloss Pewter Grey colour motorcycle bearing No.MH-03/DW-9039 having chassis No. MD2A55FXXMCL02725, Engine No.DTXCML52351 be returned to the applicant/owner **Om Prakash Amaldhari Yadav** on following conditions :-

i) The applicant/owner shall execute a suprutnama of Rs.40,000/-.

ii) Applicant/owner shall file an undertaking that, he will not change nature, design, make of the said vehicle till further orders.

3. Applicant/owner shall file an undertaking that, he shall preserve said vehicle as it is and will produce the same before the Court, as and when called during trial.

4. Applicant/owner shall file and undertaking that, he will not sale, mortgage or part with possession of the vehicle till further orders.

5. The investigation officer is hereby directed to prepare a detailed panchanama of seized vehicle, take photographs of said vehicle and file the panchanama and photographs in the charge-sheet as additional documents.

6. Compliance before this court.

7. Application is accordingly disposed off.
