**Order Below Exh.16**

1. Application is filed by accused **Rajendra Dayaram Gondhali** for release of seized vehicle in crime No.267/2024 registered at Uran Police Station for offences punishable u/s.363, 354 & 311 of the IPC and u/s.8, 9(m) & 10 of The Protection of Children From Sexual Offences Act, 2012.
2. Say of State of Maharashtra was called upon. Say is not filed by the State.

3. Heard.
4. As per accused, car model Swift (VDI BS IV) of Maruti Make having Grey Colour bearing registration No.MH-46-W-6248 which is seized in present crime is registered in his name and police have seized said vehicle as same was used by him in commission of offence.
5. Accused has produced verified copy of certificate of registration which shows that vehicle is registered in his name. He has placed on record copy of insurance which shows that insurance of vehicle is valid till 20<sup>th</sup> January 2025.
6. Accused has claimed the seized vehicle. Vehicle is lying in the police station without its use. If seized vehicle is not used then it will be rendered useless which may cause loss to accused. There is no need to keep said vehicle lying in the police station and it would be proper to handover it to accused on certain terms & conditions. For these reasons, I pass following order.

### **ORDER**

1. Application is allowed.
2. Maruti Swift (VDI BS IV) bearing registration No.MH-46-W-6248 having Engine No.D13A-313944 & Chassis No. MA3FHEB1S00329039 seized in crime No.267/2024 registered at Uran Police Station be returned to accused Rajendra Dayaram Gondhali after its insurance is obtained by accused.

3. Before handing over vehicle to accused, panchanama along with its photographs be prepared and same be produced in this Court.
4. Accused is directed to furnish indemnity bond of Rs.3,00,000/- (Rupees Three Lakhs).
5. Accused shall produce said vehicle before the Court as & when required or directed by this Court.
6. Accused shall not change body, colour or shape of vehicle. He shall not sale said vehicle without permission of this Court.
7. Accused shall produce copy of insurance on record.

(Application is disposed of accordingly)
