ORDER BELOW EXH.34 IN SPECIAL MPID CASE NO.553/2019
(DATED 08/06/2023)

1] The applicant/accused **Mahesh Janardan Patil** in Special MPID Case No.553/2019 has preferred the present application for grant of permission to reissue passport to her and permission to travel abroad at Singapore during the period of 24/06/2023 to 30/08/2023.

2] Heard Ld.Adv.for the accused. It is submitted that the applicant/accused had filed an application for reissue of passport. Applicant is a passport holder and his passport was expired on 12/06/2022. It is further submitted that, applicant is permanent resident of Nhava, Tal.Panvel and he is attending court dates regularly.

3] Ld.APP and investigation officer has raised objection for giving permission for renewal of passport.

4] Upon hearing the Ld.Advocates and on perusal record the matter is fixed for charge. It will take indefinite time for trial. Applicant is resident of Nhava, Tal.Panvel. On perusal of the notification of the concerned authority, which is in the form of gazette and after considering the undertaking given by the applicant, I am of the view that, the concerned authority can be directed to reissue passport as of the applicant/accused.

Applicant is put on conditions that, in her absence her advocate will conduct the trial without challenging the identity. The applicant to file undertaking to this effect. Hence following order.

ORDER

- 1] Application Exh.34 is allowed.
- 2] The Passport Authority is directed to reissue a passport to the applicant Mahesh Janardan Patil as per the rules and conditions mentioned in the gazette notification dated 25/08/1993, for a period of one year.
- 3] Applicant Mahesh Janardan Patil is permitted to travel to Singapore from 24/06/2023 to 30/08/2023, on condition that, during this period his advocate will attend the matter and conduct the matter in his absence.
- 4] Applicant to attend the Court dates regularly after returning from the journey.
- 5] Applicant/accused shall file an undertaking that, his advocate will conduct the matter in his absence, without challenging the identity.
- 6] Applicant is directed to furnish on record his permanent address proof as well as temporary address proof alongwith his cell number. He shall furnish on record his new address also if any.
- 7] Application is accordingly disposed of.
