Examination-in-Chief by learned APP Shri. A. D. Dhage for State

1. On 04/08/2023, we were called for signing the panchanama. Another panch Sachinkumar Madhavsing was present with us. We were called at Lohamarg Police Station. I signed on the panchanama at Police Station. Pachanama is now shown to me is the same. It bears my signature. It is marked as Exhibit 93. I do not know the contents of panchanama.

The witness resiled from his previous statement. Hence, learned APP seeks permission to ask leading question.

Cross Examination by learned APP Shri. A. D. Dhage for State

2. I have studied till 9th standard. I can read and write Marathi and English. It is true to say that, I do not signed without reading any Government document. It is true to say that, I drive the auto only in the premises of Railway Station. It is true to say that, I am acquainted with everyone around and the police. I also know the accused Wakse, Karan in this crime. It is not true to say that, I know accused No.3. It is not true to say that, on 04/08/2023 we were taken to Railway Station over bridge. It is not true to say that, there were blood stains on small stones on the spot where we were taken.

It is not true to say that, the blood stained stones were seized in our presence.

3. I do not remember whether I was called on 05/08/2023 again in the police station. It is not true to say that, the clothes on the person of the deceased were seized in our presence. Panchanama dated 05/08/2023 now shown to me. It bears my signature. It is marked as Exhibit 94. I do not remember the contents of panchanama. It is not true to say that, I am deposing false to help the accused. It is true to say that, I was talking with accused Karan before my evidence.

Cross examination by Adv.Shri. Wani for accused No.1

4. It is true to say that, as I drive a auto within the vicinity of Lohamarg Police Station I know the police. I do not have any other reason to have acquaintance with them. It is true to say that, if police require me as a panch, I go and signed. It is true to say that, I do not read the contents of panchanama while signing. It is true to say that, I was not talking anything with Karan about the case.
