

**ORDER BELOW EXH.31**

**01.** The application under consideration is filed by Mr. Damale, learned advocate representing to the respondents for referring the admitted signature of the petitioner along with disputed document pertaining to an agreement having signature which is disputed. It has been contended that the petitioner had did the job in Riyal King Sand University as I.T. Trainer for salary of 5400 Southy Riyal which would be one lac as per Indian Currency. The respondent has produced original document of agreement alleged to have signed by the petitioner but the petitioner has denied the same. Therefore, it is urged to refer the admitted signature of petitioner i.e. Vakalatnama, registered address etc. along with agreement to the Central Forensic Science Laboratory, Kharadin, Pune.

**02.** The application is resisted by the petitioner by filing say at Exh.32 thereby contended that the present proceeding is filed under the provisions of the Muslim Women Protection of Rights on Divorce Act, 1986. It is mandatory to dispose of the case within one month. The respondent may lead his evidence instead of referring the documents to the Forensic Science Laboratory. The opinion of hand writing expert is only is not binding upon the court. The petitioner is ready to give her specimen signature. The evidence on petitioner side is completed and the case is pending for the evidence of respondent but he filed such application to delay the proceeding. Therefore, it is urged for rejection of the application.

**03.** I have gone through the averment of the application and

say filed thereon. Heard the learned advocates appearing for respective parties. It is pertinent to note that the petitioner has filed the present petition under the Muslim Divorced Women Protection Act claiming maintenance for herself and for her son. Though it is presumed for a moment that the petitioner had did the job and got salary 5400 Southy Riyal but now she is residing at Tise Mohalla within the jurisdiction of this court. It means she has left Southy Arabiya and also left the job as alleged by the respondent. Therefore, it is not the contention of the respondent that the petitioner is still doing the said job from her current address that can be say as 'work from home'. Having regard to the circumstance, I am of the considered view that forwarding admitted signature and agreement containing disputed signature to the Forensic Science Laboratory will be futile. Therefore, the application is liable to be rejected. Hence, the following order.

**ORDER**

Application (Exh.31) is rejected.
