That, on 19.11.2023 at about 09.00 a.m. at Marleshwar Temple, at village Maral, Tal. Sangmeshwar, Dist. Ratnagiri, you accused No. 01 voluntarily caused hurt to the informant Yogita Gurav and thereby you have committed an offence punishable under section 323 of Indian Penal Code, 1860 and within the cognizance of this Court.

Secondly, on above date, time and place, you accused No. 01 voluntarily caused hurt to the informant's mother-in-law Vasanti Gurav and thereby you have committed an offence punishable under section 323 of Indian Penal Code, 1860 and within the cognizance of this Court.

Thirdly, on 19/11/2023, at Guravwadi, Niwdhe, Tal. Sangmeshwar, Dist. Ratnagiri, you all accused formed an assembly common object of which was to commit an offence by criminally intimidating the informant and witnesses, thereby you formed an unlawful assembly and you all were members of the said assembly and thereby you have committed an offence of being member of an unlawful assembly punishable under section 143 of Indian Penal Code, 1860 and within the cognizance of this Court.

Lastly, on 19/11/2023, at Guravwadi, Niwdhe, Tal. Sangmeshwar, Dist. Ratnagiri, you all accused persons, in prosecution of common object of your aforesaid unlawful assembly criminally intimidated the informant and witnesses that they would be killed with intent to alarm them and thereby you have committed an offence punishable under second part of section 506 read with section 149 of Indian Penal Code, 1860, and within the cognizance of this court.

And I hereby direct that you be tried on the said charge.
