**Plea under section 274 of Bharatiya Nagarik Suraksha Sanhita, 2023.**

- 1.Date of the commission of the offence :- 03.05.2024
- 2.Date of the report of Complaint :- 06.05.2024
- 3.Name of the complainant parentage age, residence. :- The State through, Police Station Sangmeshwar, Dist. Ratnagiri.
- 4.Name of the accused, parentage, age, residence. :- Dattatraya Krushna Kotawadekar, **Age- 63 years, Occu.** Agriculture, **R/o.** Burabi, Bhramanwadi, Tal. Sangmeshwar, Dist. Ratnagiri.
- 5.Particulars of the offence complained :- & explained the accused.

That on 03.05.2024 at about 02.30 p.m. on Mumbai-Goa highway, at village Dhamani, Tal. Sangmeshwar, Dist. Ratnagiri i.e. in the public place, you accused drove Auto Rickshaw bearing No. MH-08-AQ-4174 in a manner so rash or negligent as to endanger human life or personal safety of others or to be likely to cause hurt or injury to any other person and thereby committed an offence u/s.279 of the I.P.C. and within the cognizance of this Court.

Secondly, on the above date, time and place, you accused drove the above said Rickshaw so rashly or negligently as to endanger human life and having knowledge that there is traffic on highway, took U turn without giving indicator and dashed to a motorcycle bearing No. MH-08-BB-0477 and caused grievous hurt to rider named Aakash Anil Khurdekar causing him fracture to both hands and thereby you have committed an offence punishable under section 338 of I.P.C. and within the cognizance of this court.

Thirdly, on the above date, time and place, you accused drove the above said Rickshaw so rashly or negligently as to endanger human life and

having knowledge that there is traffic on highway, took U turn without giving indicator and dashed to a motorcycle bearing No. MH-08-BB-0477 and caused simple hurt to rider named Aakash Anil Khurdekar and thereby you have committed an offence punishable under section 337 of I.P.C. and within the cognizance of this court.

Lastly, on the above date, time and place you accused drove the above said vehicle in manner dangerous to the public having regard to the existing circumstances and condition of the road and traffic on the road at the time of incident and thereby committed an offence punishable under section 184 of the Motor Vehicles Act and within the cognizance of this Court.
