Ratnagiri, in discharge of your debt or other liability but, the said cheque was returned unpaid by the bank on 09.07.2020 for the reason 'funds insufficient' and thereafter the complainant issued you a notice on 07.08.2020 calling upon you to repay said amount and in spite of service of said notice on you on 13.08.2020, you failed to pay the cheque amount within 15 days from service of said notice and thereby you have committed an offence p/u/s.138 of the Negotiable Instruments Act, 1881 and within the cognizance of this Court.
