JUDGMENT**(Delivered on 18th October 2023)**

Accused is present in person before the Court. I have given him understanding and the consequences of admitting the guilt. He has admitted the guilt. He has prayed that minimum fine be imposed. Taking into consideration, the nature of offence, I proceed to pass the following order :-

ORDER

1) Accused Shanta Anil Gharat is convicted for the offence under section 7 (2) P/U/S. 20 (2) of Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, supply and Distribution) Act, 2003 vide section 252 of the Code of Criminal Procedure.

2] Accused is sentenced to pay fine of Rs.500/- (Five Hundred Rupees) for the offence under section 7 (2) P/U/S. 20(2) of Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, supply and Distribution) Act, 2003 in default to suffer simple imprisonment for Seven days.
