Secondly, on the above date, time and place, you accused no. 1 abused the informant by saying that, “you shall sleep with me” and you uttered these words with view to insult her modesty and thereby you have committed an offence p/u/s.509 of Indian Penal Code, 1860 and within the cognizance of this Court.
