05. Considering oral arguments of Ld. Advocates of both parties and death certificate, in the interest of justice and in order to decide the suit on merits, I pass following order :-

ORDER

1. The application is allowed, subject to cost of Rs.400/- payable in the Court and credited to the Government.
2. Legal Representative No. 1 of deceased plaintiff i.e. applicant is allowed to take necessary steps for taking on record legal representatives of plaintiff Gangaram Sonu Ghole on or before next date after depositing above said cost amount in the Court.
