Notice issued to defendants No.1, 8, 6(b) through RC/AD. However, RC/AD not received back. RC/AD of defendants No.1, 8, 6(b) be awaited for 24.09.2026.

Notice issued to defendants No.2 and 9 received back with the report of not met. Plaintiffs are directed to file correct address

and complete present address of defendants No.2 and 9 and thereafter, notice to defendants No.2 and 9 be issued through RC/AD for 24.09.2026.

As per report of Ahlmad, correct address of defendants No.3, 4(c to e), 6(a)(i)/7(a), 6(a)(ii)/7(b), 6(a)(iii)/7(c) not filed. Plaintiffs are directed to file correct and complete present address of defendants No.3, 4(c to e), 6(a)(i)/7(a), 6(a)(ii)/7(b), 6(a)(iii)/7(c) and thereafter, notice to these defendants through RC/RC be issued for 07.08.2026, subject to last opportunity and subject to previous cost of Rs.500/- to be deposited in DLSA, Rupnagar failing which suit against these defendants will be dismissed.
