ORDER

(Passed on 28/04/2026)

- 1] This is an application filed by the applicant namely Kum. Kashyap Sachin Sakulkar for Legal Heir-ship Certificate.
- 2] It is contention of applicant that, deceased Sachin Vasant Sakulkar is his father. He died on 28/10/2025. The applicant is residing with his mother Sangitta Dattaram Naik. Marriage of his mother and father is dissolved by order in Marriage Petition No. 171/2019. Therefore, applicant is the only legal heir of his deceased father. Deceased Sachin Vasant Sakulkar was serving in Rural Water supply Department (Z.P.), Sawantwadi. Applicant sought Legal Heir-ship certificate for obtaining various monetary benefits and job on compassionate ground.
- 3] The applicant claiming himself to be legal heir of deceased Sachin Vasant Sakulkar.
- 4] On perusal of record, it appears that applicant has published the Notice in daily newspaper "Sakal" on 21/01/2026. The newspaper is available at Exh.16. Citation notice vide Exh. 06 issued and published at Notice Board of Tahasildar Office Sawantwadi, Nagar Parishad Sawantwadi, Public Place in Sawantwadi, Notice Board of Civil Court, Sawantwadi and on notice board of Grampanchayat,

Kolgaon. Since then objections have not raised by anyone as to claim of the applicant.

5] Thereafter, guardian of applicant has filed her affidavit of evidence at Exh.10. She has also filed Death Certificate of deceased Sachin Vasant Sakulkar at Exh.11, letter given by Rural Water supply Department (Z.P.), Sawantwadi at exh. 12, copies of Aadhar Card of Applicant and guardian Exh. 13 and 14, copy of ration card of applicant at Exh,15. Thereafter, Evidence of applicant closed vide Pursis at Exh.17.

6] I have heard learned Advocate for applicant.

7] In the present case, the applicant is son of deceased born from the marriage. Marriage of his parents is dissolved by divorce. Therefore mother of applicant is not entitled for heirship certificate. The death of deceased Sachin Vasant Sakulkar is established by Death Certificate at Exh.11. The assertion of applicant is intact as nobody has objected his claim. Considering the claim, I am of the view that the Certificate of Heir-ship needs to be granted in favour of applicant. I find no reason to reject or refuse Certification. Therefore, I pass the following order

ORDER

Issue Heir-ship Certificate in the name of applicant Kum. Kashyap Sachin Sakulkar as legal heir of deceased Sachin Vasant Sakulkar in view of Rule 2 and 3 of Bombay Regulation Act - VIII, 1827 in prescribed Form available in Schedule of Regulation Act.
