**ORDER**

(Passed on 11/03/2026)

1] This is an application filed by the applicants namely 1- Smt. Pranali Pravin Parab, 2- Kum. Pranjal Pravin Parab and 3- Kum. Khushi Pravin Parab for Legal Heir-ship Certificate.

2] It is contention of applicants that, deceased Pravin Narayan Parab is husband of applicant no.1 and father of applicant no.2 and 3. He died on 27/06/2024. Applicants are the only legal heirs of deceased. They sought Legal Heir-ship certificate for entering their name in R. C. Book of Honda motorcycle bearing registration no. MH-07/AL-1192 which is standing in the name of deceased.

3] The applicant claiming themselves to be legal heirs of deceased Pravin Narayan Parab.

4] On perusal of record, it appears that applicant has published the Notice in daily newspaper "Sakal" on 22/07/2025. The newspaper is available at Exh.23. Citation notice vide Exh. 06 issued and published on notice board of Tahasildar Office Sawantwadi, notice board of Civil Court, Sawantwadi, notice board of Grampanchayat, Kariwade on notice board of public place in Kariwade. Since then objections have not raised by anyone as to claim of the applicant. Notice issued to non-applicant. They filed their say in respect of particulars of vehicle Hero Honda Motorcycle No. MH-07/AL-1192 which is standing in the name of deceased.

5] Thereafter, applicant has filed her affidavit of evidence at Exh.13. Applicant has also filed Death Certificate of deceased Pravin Narayan Parab is at Exh.14, copy of marriage certificate of applicant at Exh. 15, copy of ration card of applicant at Exh. 16, copy of R. C. Book of Honda motorcycle bearing registration no. MH-07/AL-1192 at Exh.17, copy of letter dated 3/3/2025 given by R.T.O., Sindudurg at Exh. 18, copy of election card of deceased Pravin Narayan Parab is at Exh.19, copy of election card of applicant at Exh. 20, copy of pan card of deceased Pravin Narayan Parab is at Exh.21 and copy of pan card of applicant at Exh. 22. Thereafter, applicant has closed her evidence vide Pursis at Exh.24.

6] I have heard Ld. Advocate for applicants.

7] In the present case, the death of deceased Pravin Narayan Parab is established by Death Certificate at Exh.14. The assertion of applicants is intact as nobody has objected their claim. Considering the claim, I am of the view that the Certificate of Heir-ship needs to be granted in favour of applicants. I find no reason to reject or refuse Certification. Therefore, I pass the following order :-

**ORDER**

Issue Heir-ship Certificate in the name of applicant namely 1- Smt. Pranali Pravin Parab, 2- Kum. Pranjal Pravin Parab and 3- Kum. Khushi Pravin Parab as legal heirs of deceased Pravin Narayan Parab in view of Rule 2 and 3 of Bombay Regulation Act - VIII, 1827 in prescribed Form available in Schedule of Regulation Act.
