- 5] Particulars of Offence :

Firstly, that you accused person, on 29/09/2023, at about 02.45 p.m., on Budhavale to Chindar road, at Kudopi Madhaliwadi drove a motorcycle bearing registration No.MH-04-GL-5572 in a manner so rash or negligent as to endanger human life, or to be likely to cause hurt or injury to any other person, and thereby you have committed an offence punishable under **Section 279** of the Indian Penal Code and within my cognizance.

Secondly, that you accused person, on the above said date, time and place, you caused grievous hurt to informant

namely Gurunath Bhau Ghadi and Rahul Gurunath Ghadi, by doing such act so rashly or negligently, so as endanger human life or the personal safety of others and thereby you have committed an offence punishable under **Section 338** of the Indian Penal Code and within my cognizance.

Thirdly, that you accused person, on the above said date, time and place you have caused simple hurt to yourself and Datta Shridhar Walave by driving above said vehicle so rashly or negligently, so as endanger human life or the personal safety of others and thereby you have committed an offence punishable under **Section 337** of the Indian Penal Code and within my cognizance.

Fourthly, that you accused person, on the above date, time and at place drove aforesaid vehicle at a speed or in a manner which was dangerous to public having regard to the circumstances of the case, and thereby you have committed an offence punishable under **Section 184** of the Motor Vehicle Act and within my cognizance.

Fifthly, that you accused person, on above date, time and at place you have driven aforesaid vehicle without having third party insurance and thereby you have contravened Section 146 of Motor Vehicle Act and thereby you have committed an offence punishable under **Section 196 r.w. Section 146** of Motor Vehicle Act and within my cognizance.

Lastly, that you accused person, on above date, time and at place you have driven aforesaid vehicle without certificate of air-pollution and thereby you have committed an offence punishable

under **Section 190(2)** of Motor Vehicle Act and within my cognizance.

And I hereby direct that you be tried for the said offence by this court.
