**-: ORDER BELOW EXH. NO. 27 :-**

This is an application filed on behalf of the applicants i.e. the legal representative of the plaintiff to bring legal heirs of plaintiff on record.

**02.** It is contended that, Plaintiff Shri. Parshuram Arjun Dalavi died on 10.12.2021. That, he is survived by -

1. Smt. Amita Parshuram Dalavi (Wife)  
Age about 56 years, Occu. – Household.
2. Shri. Nakul Parshuram Dalavi (Son)  
Age about 30 years, Occu. – Service.
3. Smt. Mangal Pandurang Thanekar  
before marriage-Bhima Parshuram Dalvi  
Age about 35 years, Occu. – Household.
4. Kum. Kasturi Parshuram Dalvi  
Age about 28 years, Occu. – Household.  
All R/o – Talekhol, Dodamarg,  
Tal. Dodamarg, Dist. Sindhudurg.

It is further contended that, the plaintiff being dead, his legal representative are required to be taken on record. Hence, it is prayed that, the legal representative be taken on record and application be allowed.

**03.** The defendants did not file any say on the application. Hence the application proceeded without say of the defendants.

**04.** It can be seen that, the present applicant Nakul Parshuram Dalvi is the son of the plaintiff. The plaintiff is informed to have been died on 10.12.2021. The copy of his death certificate has been filed alongwith the list at Exh. 29. Thus, the plaintiff being dead, his right to sue is survived by his legal representative.

1. Smt. Amita Parshuram Dalavi (Wife)  
Age about 56 years, Occu. – Household.
2. Shri. Nakul Parshuram Dalavi (Son)  
Age about 30 years, Occu. – Service.
3. Smt. Mangal Pandurang Thanekar  
before marriage-Bhima Parshuram Dalvi  
Age about 35 years, Occu. – Household.
4. Kum. Kasturi Parshuram Dalvi  
Age about 28 years, Occu. – Household.  
All R/o – Talekhol, Dodamarg,  
Tal. Dodamarg, Dist. Sindhudurg.

Hence, the legal representative of the plaintiff are required to be taken on record and necessary amendment is required to be carried out in the plaint. The application has been filed within limitation. Hence the application is required to be allowed without any order as to cost. Accordingly, I proceed to pass the following :

### **ORDER**

1. The application is allowed without any costs.

2. The legal representatives of the plaintiff is allowed to be taken on record.
3. Plaintiff to make necessary amendment as prayed in the plaint and filed copy of amended plaint within 14 days from the date of this order.
