(Tushar Bele etc. Vs. Vikas Kolekar etc.)

1. This application is filed by the plaintiff to exhibit document filed along with list Exh.3/9 to 3/18 and 3/02 to 3/06.
2. Say of the defendant has been called on it, who strongly opposed the application for exhibiting the document as the some of the documents are xerox copies and some are private documents, hence they needs to be proved.

to be proved and cannot be exhibited at this state. The document at Sr.No.12 is public notice of newspaper hence it be exhibited. The document at Sr.No.13 is office copy of notice, hence it be exhibited. The documents at Sr.No.14 are acknowledgments hence those be exhibited. The document at Sr.No.15 is original reply notice received by the plaintiff, hence it be exhibited. The document at Sr.No.16 are original returned envelop of notices hence it be exhibited. The document at Sr.No.17 is document of form No.16 in Kannad language and its translation by Adv.Sanadi. Without examination of said advocate it cannot be said to be proved and it cannot be exhibited at this stage. The document at Sr.No.2 is form No.8 it be exhibited.
