JUDGMENT

Accused is prosecuted for offence punishable under section 185 of the Motor Vehicles Act.

Accused is present before me. The particulars of the offence were read over and explained to accused. He pleaded guilty and voluntarily admitted the commission of offence. The accused has filed pursis pleading guilty voluntarily. I have personally verified the contents of the pursis from the accused. He admitted the contents of the pursis. Hence the pursis is read and recorded. I have asked accused on the point of sentence. He submits that he is poor and his whole family is depending upon him. The accused prayed for leniency and also submitted that minimum punishment be awarded to him.

Under such circumstances, considering the facts of the

present case and nature of offence, I proceed to pass following order.

ORDER

Accused is hereby convicted for the offence punishable under section 185 of the Motor Vehicles Act, 1988 vide section 275 of the B.N.S.S.Act, 2023 and he is sentenced to pay fine of Rs. 2,000/- (Rs. Two Thousand only) in default to suffer simple imprisonment for five days.
